

3. Judgment is hereby entered in favor of plaintiff Pamela Goodpaster against defendant Eric C. Deters and other party Deters & Associates, P.S.C., jointly and severally, in the principal sum of Forty-Five Thousand and 00/100 Dollars (\$45,000.00).

4. Execution on this judgment is stayed until November 17, 2016 (the last day of the stay being in force is November 16, 2016), as well as the accrual of interest on the aforesaid judgment amount.

5. Each party shall bear his or her own expenses and attorney's fees in the prosecution or defense of this action. Court costs shall be divided between plaintiff and defendant on the basis of who filed the pleading or document, and any court costs for orders and entries of the Court shall be equally split between plaintiff and defendant.


6. This is a final and appealable judgment, there being no just reason for delay.






