#### Tri-state will be destroved 🗈



Officials at the Earthquake Prediction Center (EPC) now foresee a shift of the earthquake predicted to hit the Greater Cincinnati area on Dec. 3.

Instead of taking place along the New Madrid fault, the earthquake's epicenter should occur directly beneath Fifth and Vine Streets in Downtown Cincinnati.

Originally, Iben Browning, a New Mexico climatologist, had said there was a 50-50 chance an earthquake

capable of great damage will hit along the New Madrid fault Dec. 3-give or take a day or two.

Browning's prediction is now more precise. The quake will occur at 10:15 a.m., with preshocks beginning at 9:27. Aftershocks are estimated to last throughout the afternoon.

Weathermen at all local television stations agree that an earthquake will destroy the city.

### "Don't panic, "county officials say

Predictions of the Dec. 3 earthquake have Tri-state residents in a panic, "We need to calm this down a



little bit,' Liore Maccarone. civil defense chief Hamilton County, said Thursday.

The Hamilton County Emergency Management Agency has been inundated with

phone calls from worried residents. "We've literally come to a screeching halt on day-to-day business and are devoting all our time to answering phones, mailing out pamphlets and getting information out," Maccarone

"It's really got some people concerned, especially the elderly. You just cannot get those people off the telephone. You actually have to stay on the phone and calm them.'

County Engineer Don Schramm says that there should be no problem with an orderly evacuation, since all bridges have been recently inspected.

 Strap the water heater to a wall.
 Bolt bookcases and other tall, heavy furniture to the wall.

Put bolts or latches on cabinet doors.

Take a First Aid/CPR course from your local Red Cross chapter.

#### Prepare a Group Sex Earthquake Safety Kit

- Condoms
- · First aid kit
- · Fire extinguisher
- · Canned food and a can opener
- Bottled water
- Sturdy shoes and work gloves
- Extra blankets and trash bags
- Essential medications
- Battery-powered vibrator, flashlight, and extra batteries

Also include in the kit written instructions on how to turn off your

#### What to do when all the shaking begins

If you're inside, go only a few steps to a safety spot you have already picked. It could be a heavy desk or table you could crouch under (and hold on to) to be safe from falling objects...just an inside corner of a room. Pick a spot away from windows, bookcases, or tall heavy furniture that could fall on you.

If you're in a high-rise building, don't be surprised if the fire alarms and sprinklers do off while you're having group sex during a quake.

If you are outside, find a clear spot away from buildings, trees, and power lines.

If you're in a car, drive to a clear spot (as above) and stay in the car until the shaking stops.

#### What to do after all the shaking stops

Be prepared for aftershocks. Check people for injuries. Give first aid.

Inspect your home for damage.
Listen to the radio for instruc-

Go to a Red Cross shelter if your home is unsafe.

#### Always remember

To tell your partner you didn't know there was an earthquake.

Members of both groups and their guests are advised to arrive early.



Leftover squid tips



When the Free Store started giving out all that squid right before Thanksgiving, many homemakers began calling to ask about leftovers.

· As soon as the Thanksgiving meal is over, slice, dice, package your squid and then refrigerate.

 If your squid is stuffed, spoon the stuffing into a container and chill separately...

. Store any leftover gravy in a refrigerator container and save to use for moistening the squid slices and leftover stuffing when reheating.

· Package the slices and the diced squid meat separately since they are likely to be used in different dishes, sandwiches, etc.

 Store squid in plastic bags or containers so that they are protected from drying out. Store in meat drawer or other cold section of the refrigera-

. If squid is to be frozen, put it in proper packaging. Three months should be maximum time in the freezer. Thaw in refrigerator.

Curried Squid with Rice

- 4 tablespoons butter or margarine
- 2 Cup chopped onion
- teaspoon Madras curry powder
- 1 teaspoon chili powder
- 3 tablespoons flour
- 1 cup squid broth, heated
- 1 clove garlic, finely minced
- 1 tablespoon finely minced ginger
- 2 Cup chopped roasted, unsalted cashew nuts
  - 2 Cup flaked coconut
  - 1 cup cream
  - 3 cups diced or sliced cooked squid Salt and Tabasco, to taste
- Chopped cilantro leaves or parsley leaves, for garnish
