

Issue # 16, Sept. 11: County spending millions to combat Whistle-blower. Mickey Esposito gets new job. Celebreeze announces his next stand on abortion. Council agrees to pay new city manager Gerald Newfarmer \$125,000. Pete Rose predicts winners of Nov. elections. Dennis Barrie promises "no more dirty pictures."

Issue # 17, Sept. 18: Low voter turnout predicted. Tyrone Yates doubles campaign warchest now has \$200.00--for campaign against Gradison. County employee publications exposed as wasteful, poorly written.
